General Terms and Conditions:

Booth Information

- 10'x10' booth spaces are available to restaurants serving chili and breweries serving beer.
- Booth space includes standard electricity.
- Vendors must provide all needed supplies, including tables and extension cords.
- All vendors must remain for the entire event.

Fees

- 10'x10' booth = \$50.00
- Full payment is due at the time of registration. Payments can be made via check to City of Saint Charles or by credit card (with a small processing fee). Please call 636-949-3301 with credit card information after sending in completed application.

Samples

- Guests will have the option to purchase a chili and beer sampling ticket. All vendors are required to provide samples to attendees with a sampling ticket.
- Guests will purchase all other food and all beverages.

Favorite Chili/Beer Competition

- By registering all chili and beer vendors will be entering the competition for favorite chili/beer.
- Attendees will vote on their favorite chili and favorite beer and a top winner will be awarded in each category. Winners will receive \$500 and bragging rights!

Set-up/Clean-up

- Set-up will begin at 9:00 A.M. on January 28th. All booths must be set-up by 10:30 A.M.
- Please keep all packing materials out of sight and stay in your designated area.
- All vendor spaces must be disassembled by 8:00 P.M. Please leave your booth space and surrounding area free of trash and debris.

Permits

- Vendors are required to apply for a temporary permit with the St. Charles County Health Department, unless you are already licensed with the County.
- Vendors with a St. Charles County health license must display a copy at their booth.



Waivers of Liability Requirements

- Vendors retain sole responsibility for their merchandise throughout the Bowls and Brews event. Vendors shall release, indemnify, defend and hold harmless The City of Saint Charles, its elected and appointed officials, successors, assigns, legal representatives, officers, employees, and agents (collectively, “indemnities”) for, from and against any and all claims, liabilities, cost damages, losses, causes of action, suits, demands, judgments and expenses (including, without limitation, court costs, attorneys’ fees and costs of investigation or otherwise (collectively “liabilities”) of any nature, kind or description of any person or entity directly or indirectly arising out of, resulting from or related to (in whole or in part) merchandise loss or property damage of any kind whatsoever resulting from or connected to the operation of Vendor’s area.
